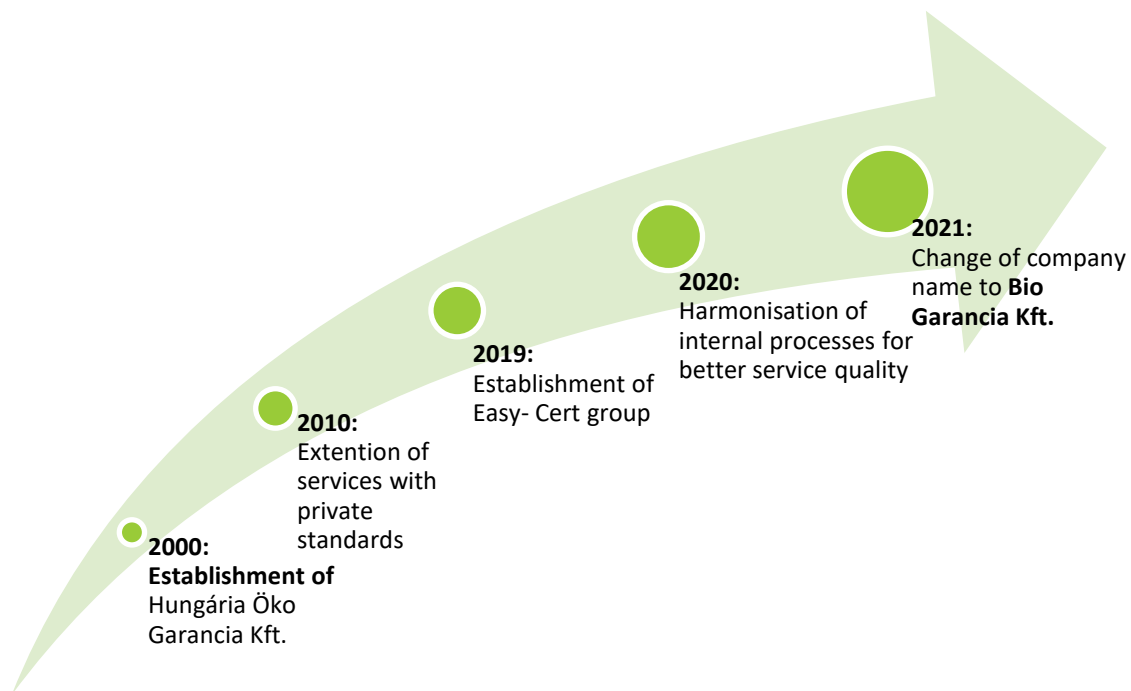
Biokontroll Hungária Nonprofit Ltd. is a 100% Hungarian-owned organic control body registered with the code number HU-ÖKO-01 by the Hungarian competent authority. Our operation is limited to the territory of Hungary. The scope of our activities includes inspection and certification in the following fields: crop production, animal husbandry (including several species which are not regulated by EU organic legislation) wild collection, bee-keeping, retail and wholesale, import and export, processing, winemaking and manufacturing of cosmetic products. We help our clients obtaining approval and certification according to the biodynamic standards of Demeter International as well as the standards of Bio Suisse, Naturland, Bioland or KRAV. We have been members of IFOAM Organics International and IFOAM Organics Europe for 19 years.





Established in 2000 Hungária Öko Garancia Kft. is an internationally recognized, independent, accredited certification body, and the member of Easy-Cert group which is one of the leading organic certification bodies in Europe. Our company complies with the regulations of Hungary and the EU necessary for its operation, therefore it acts as a certification body acknowledged by the National Food Chain Safety Office (NeBiH) and the National Accreditation Authority (NAH).

The Easy-Cert group was established in year 2019 by the leading certification bodies of Austria and Switzerland –**Austria Bio Garantie (ABG)** and **bio.inspecta** -, with the German CERES and other small certification bodies also joining to the group. The group of companies conducts altogether 40.000 audits per year in 38 countries, most of which consist of the inspection of organic farmers, processors, traders, importers, and also inspects another 150 private standards, which includes the organic food trademarks, eco-textiles, organic cosmetics, as well as sustainability standards. As a result of this clients of Easy-Cert group and Hungária Öko Garancia Kft. can benefit from an ever bigger range of services. Following the harmonisation of our internal processes in 2020, our company name will be also unified in Spring 2021 and the successor of our company will be **Bio Garancia Kft.**
